

DEMOCRATIC PARTY OF SACRAMENTO COUNTY

CENTRAL COMMITTEE MEETING MINUTES

1/9/2020 – Curtis Hall, Sacramento

The regular monthly meeting of the Sacramento County Democratic Central Committee, held at the Sierra II Center's Curtis Hall on Thursday evening, January 9, 2020, was called to order at seven minutes past six P.M., Mr. Schanz being in the Chair and Mr. Becker as Secretary.

The Chair called the roll [see Attachment 1], and noted the presence of a quorum.

The agenda was adopted as amended.

The minutes were approved as distributed.

New Members were sworn-in.

The Controller delivered her report. The Party had \$76,400.⁹⁶ in its State Account and \$3,234.⁵⁰ in its Federal Account.

The Chair delivered his report. At the CDP's Convention in Long Beach, the CDP Rules Committee heard two challenges brought against the DPSC—one by Mr. Steve Hansen and another by Mr. Jay Hansen. Both complaints were dismissed for having no merit. Filing to be elected delegate to the Democratic National Convention is now open until the 3rd of March.

The Chair placed an Endorsement Consent Calendar before the Committee for consideration consisting of the following races and endorsement recommendations: Sacramento Mayor, Darrell Steinberg; Sacramento City Council District 2, Allen Warren; Twin Rivers Unified School District

Area 3, Christine Jefferson; Twin Rivers Unified School District Area 7, Daniel Savala; Measure D, Support; Measure E, Support; Measure H, Support. Ms. Molander asked that Measure H be removed from the Endorsement Consent Calendar, which was 2nded and 3rded. Ms. L'Ecluse asked that the Twin Rivers Unified School District Area 7 race be removed from the Endorsement Consent Calendar, which was 2nded and 3rded. Mr. Fong asked that the Sacramento City Council District 2 race be removed from the Endorsement Consent Calendar, which was 2nded and 3rded. Mr. Baretto asked that the Sacramento Mayoral race be removed from the Endorsement Consent Calendar, which was 2nded and 3rded. Remaining on the Consent Calendar: Twin Rivers Unified School District Area 3, Christine Jefferson; Measure D, Support; and Measure E, Support. Hearing no further requests, the Chair placed the Endorsement Consent Calendar before the Committee, which passed.

The Chair placed consideration of endorsement in the Sacramento Mayoral race before the Committee. The Chair allowed a representative of Darrell Steinberg and Jrmar Jefferson to speak, followed by supporters of each candidate and of no endorsement. After debate, balloting commenced.

The Chair placed consideration of endorsement

in the Sacramento City Council District 2 race before the Committee. The Chair allowed a representative of Earl Warren and Ramona Landeros to speak, followed by supporters of each candidate and of no endorsement. After debate, balloting commenced.

The Chair placed consideration of endorsement in the Twin Rivers Unified School District Area 7 race before the Committee. The Chair allowed a representative of Daniel Savala and Sascha Vogt to speak, followed by supporters of each candidate and of no endorsement. After debate, balloting commenced.

The Chair placed consideration of endorsement regarding Measure H before the Committee. The Chair allowed Sacramento City Unified School District Board of Education Trustee Lisa Murkowski to speak in favor and Anna Molander to speak in opposition, followed by supporters of each position and of no endorsement.

The Chair placed consideration of endorsement regarding Measure G before the Committee, which was forwarded to the Central Committee without a recommendation from the Executive Board. The Chair allowed Sarah-Michael Gaston of Youth Forward to speak in favor and Sacramento Public Library Director Rivkah Sass to speak in opposition, followed by supporters of each position and of no endorsement.

Balloting commenced.

The Chair put the appointment of an Audit Committee consisting of the following members before the Committee: Adrian Mohammed,

Brandon Black, David Clements, and Michelle Pariset. The appointments were approved.

The Chair put the consideration of requests for charters for two Democratic Clubs before the Committee: College Democrats at Sacramento State and Sacramento Democrats for Justice in Palestine. Seeing no debate, the Chair put the question of granting the two charters before the Committee, which passed.

The Chair put the consideration of the cancelation of the February and October Central Committee meetings (in favor of directing members to DPSC campaign activities instead) before the Committee, which passed.

Standing Committee reports were delivered.

Club reports were heard.

Announcements were heard.

The Chair announced the results of the vote on endorsing in the Sacramento Mayoral election: the motion to endorse Darrell Steinberg passed with 34 yeas and 11 nays.

The Chair announced the results of the vote on endorsing in the Sacramento City Council District 2 election: the motion to endorse Allen Warren passed with 35 yeas and 13 nays.

The Chair announced the results of the vote on endorsing in the Twin Rivers Unified School District Area 7 election: the motion to endorse Daniel Savala failed with 40 nays and 7 yeas.

The Chair announced the results of the vote on endorsing in the Measure H election: the motion to endorse Measure H passed with 30 yeas and 18 nays.

The Chair announced the results of the vote on endorsing in the Measure G election: the Committee took no position on Measure G, with 24 votes to Support, 20 votes to Oppose, and 4 votes for No Endorsement.

Mr. Ramos asked for a voice vote to formally adopt a position of Neutral in the Twin Rivers Unified School District Area 7 election, which passed.

Mr. Ramos asked for a voice vote to formally adopt a position of Neutral in the Measure G election, which passed.

Upon unanimous consent, the Chair adjourned the meeting at thirteen minutes past nine o'clock.
